**MECHANIC & MAINTENANCE REPAIRMAN (ELECTRICIAN)**

**SUMMARY:** In accordance with our most recent Union Agreement Article XIX, section 1, employees are hereby notified that the South Jersey Port Corporation will be accepting applications from employees for Maintenance Electrician. The successful applicant will perform maintenance functions at all South Jersey Port Corporation facilities. The success applicant will be paid in accordance with current labor contract as:

First 480 Hours After Appointment	\$30.34 per hour Effective 7/01/19
After 480 Hours Continuous Service In New Job Classification	\$30.64 per hour Effective 7/01/19

**JOB REQUIREMENTS:**

Mechanic and Maintenance Repairman (Electrician) must be qualified and experienced (minimum 5 years) to perform journeyman level work or equivalent formal training in the electrical field. Must be able to install, maintain, inspect, repair and service high and low tension power and lighting feeders, generating and control equipment, relays, transformers, motors, pumps, switches, outlets, appliances and conduit fittings, cables, insulators and ohmmeters; troubleshoot various malfunctions and breakdowns and make appropriate repairs and recommendations; prepare and/or work from electrical schematics, plans, blueprints and specifications in accordance with the electrical code or accepted trade practices; make time and material estimates; inspect work in progress for defects, fire hazards or other unsafe conditions and notify supervisor of these conditions.

A daily work sheet must be handed into the supervisor at the end of each day, also, prepare reports and keep needed records. Must perform all phases of maintenance work, in addition to electrical work, as required. Must be willing to work at heights in and on buildings, structures, and cranes at SJPC Facilities. Must have appropriate tools for the electrical trade and all phases of maintenance work. Must follow all safety rules as required by SJPC.

The New Jersey First Act, effective September 1, 2011, established residency requirements for all public employees. The applicant shall have their principal residence in the State of New Jersey.

- Must possess a Federal Transportation Worker Identification Credential issued by the Transportation Security Administration.
- Must possess a valid, unrevoked, and unsuspended driver's license.

**TESTING:**

All applicants for this job opening must be willing to take a written test to demonstrate qualification in one or all the above areas of specialization. A practical test in these areas will also be required. Management will judge whether an applicant is qualified for this position. Certain portions of the examination procedure may be waived by Management based on an applicant's experience in performing this level of work.
